- 2. In terms of Circular No. IBBI/CIRP/016/2018 dated August 10, 2018, kindly note that each member of CoC (other than creditors mentioned under Section 21 (6A) (b) of the Insolvency and Bankruptcy Code, 2016) must be represented in the CoC by such persons who are competent and are authorised to take decisions in the meeting and without deferring decisions for want of any internal approval from the Financial Creditors represented by them.
- 3. In terms of provisions of Regulation 25(3) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016, the vote of members of the Committee present in the meeting shall be taken at the meeting, on any item listed for voting after discussion on the same. Those members who didn't vote at the meeting can vote through e-voting system which shall be opened post-circulation of minutes for at least twenty-four hours from circulation of minutes of the meeting. In case all members present in meeting also vote in the meeting, e-voting system will not be activated.

At the conclusion of voting, the decision taken of the items along with the names of the Members of the CoC who voted for or against the decision, or abstained from voting will be announced.

- 6. In terms of provisions of Regulation 20(6) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations, 2016, the notice is made available on the website of the Corporate Debtor i.e., <u>https://jaatvedas.com/</u> and full details of how to access the document or information is given hereunder:

- 7. The Directors of the Corporate Debtor attending the meeting, shall not have any right to vote at the meeting and shall not form a part of the quorum.
- 8. Based on the status of claims received, only one claim has been received (verified) from a financial creditor and 48 claims were received (verified) from operational creditors one of the operational creditors as on 7-10-20222. Accordingly, the Committee of Creditors has been constituted with the said financial creditor. In case other claims which may be received / have been received from other financial creditors after 7-10-2022 are admitted, the committee shall be reconstituted to that effect and voting share shall be changed to that effect from time to time.
- 9. In terms of Regulation 13(2) of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate Persons) Regulations 2016, ("IBBI Regulations"), the list of creditors is available for inspection with prior notice to all participants of the committee meetings.

ANNEXURE – A

INSTRUCTIONS FOR E-VOTING:

- i. <u>START AND END TIME</u>: The e-voting period will commence on 48 hours after completion of the meeting and shall continue for further 48 hours from such commencement. During this period, the members of the Committee of Creditors are being provided the platform to cast their vote electronically. The e-voting module shall be disabled by Right2Vote for voting thereafter.
- ii. <u>WEBSITE LINK:</u> The participating members of the Committee of Creditors should log on to the e-voting website <u>https://right2vote.in/login/</u> during the voting period.
- iii. <u>USER ID</u>: Enter your Email ID. <u>Your Email ID is your user ID</u>. Kindly ensure you use the same Email ID as notified to the IRP for eVoting.
 You will also receive an INVITE mail from Right2Vote on this email ID and the mail will have the link, user ID and other details mentioned. Do not try to log in with mobile number if you have received the invite on the email.
- iv. <u>PASSWORD</u>: Press GET OTP. OTP (One Time Password) would be <u>delivered on your Email.</u> The
 OTP is the password. Once you enter the OTP and press Sign In, you would be logged in.
- v. <u>VOTING PAGE</u>: Once logged in, you would be directed to MY POLL INVITE page. Here you would see the poll from the JAATVEDAS CONSTRUCTION CO. PVT LTD listed. Click on the poll and you would be taken to voting page.
